A motion was made to purchase the plaque ( $\$ 500-600$ ) and three stones (for a maximum of $\$ 500$ ) by Jean Nelson/2 ${ }^{\text {nd }}$ by Rick Sironi. Motion carried. By purchasing three stones we are making room for future use.

We have applied for and received approval for a grant from Walmart for our Fun Day in the amount of $\$ 1000$. We are just waiting for the check to arrive.

It was decided that we should be asking the town to pay half and, in addition, there is money in the Fire Department's budget already allocated for EMS. All our AED's are at least 11 years old, one as old as 15 . The range of cost for four units total is $\$ 4000-\$ 5000$. EMS has applied for one grant already. A motion was made to buy four AED's by Tom Birchell/2 ${ }^{\text {nd }}$ by Warren Johnson. Motion carried.
