Jim Nelson would like to buy a grill cover for the new brat/hot dog grill. A motion was made to buy a grill cover not to exceed \$100 by Tom Birchell/2nd by Rick Sironi. Motion carried.

Jean Nelson reported back from the town hall meeting last week. The Pike Lake area and the Town of Fifield proper will no longer have separate tax levies. This means Pike Lake area taxes will go up about \$.50 per \$1000 property value which translates into about an average of \$100-200 raise in taxes. The Town of Fifield proper will see their taxes go down. The town board already voted to make it one department and therefore one tax levy for both areas. The question is, can we ever legally go back to two separate departments with two separate levies. There was discussion about not having Fun Day due to these circumstances. A motion was made to table the decision to continue or cancel Fun Day and not spend any more funds until that decision is made by Terry Mantor/2^{nds} by Mike Sloane. Motion carried.

Whatever decision is made on the future of Fun Day it has no impact on the Pike Lake Fire and EMS response to calls. It is a financial impact to our taxes.

Fire Chiefs Report:

Warren Johnson reported there was a one vehicle accident on Hwy 70. All future monies will be requested from our budget from the town and not from FF Inc.

Motion to Adjourn:

A motion to adjourn was made by Rick Sironi/2nd Tom Birchell. Motion carried. Meeting adjourned at 8:06 pm.
