**Old Business:**

Food and drink tickets were discussed again. We would need a building, tickets and people to man the sales. It was asked if there was anyone willing to head this up. No one stepped forward at this time. We will bring it up at our September Thank You Dinner for consideration next year.

The ice cream freezer temperature was checked out using a thermometer and it was at zero. Terri Murrin's husband, Tom, will be checking it out for us next week as that is his line of work. Someone has a chest freezer they are willing to donate. We are going to look at the option of having a second freezer on hand to keep the stock cold.

A money counter was picked up by Jim and Pat Gurtner at Sam's Club in Madison at a cost of \$210. The Gurtner's kindly donated the money counter to FF Inc.

#### **New Business:**

Sandy Sironi brought in a mock up for Pike Lake Chain sweatshirts. There was concern about the quality of the shirts and a show of hands showed that there was no interest. Permission was granted to have a sign up, no money collected, for the sweatshirts should the Lake Association decide they would be willing to sell them.

#### **Fire Chief's Report:**

We received a thank you and a \$100 donation from Flambeau Home Hospice after we had to help them out with an extraction. There was a call involving mutual aid on Amik Lake with Flambeau. We picked up our new UTV and turned the bill into the town and gave Susan a copy of the bill. Currently we are looking for a trailer. Our old six wheeler and trailer are going to be advertised and will be bid on at the town board meeting in August. The bidding will close at 6:00 pm on the first Thursday in August. Our fire engine will be going to the 4<sup>th</sup> of July parade in Lac du Flambeau. Terry was looking for firefighters to man the engine for Flambeau Rama and Pioneer Days at Butternut. Les Nordrum and Paul Kronberger volunteered.
