## Fire Chief's Report:

We have had no calls recently. Our UTV is in working order and will be on display at Fun Day. Terry brought up a request to have the floor in the fire house replaced for a cost of approximately $\$ 9,000$ and new LDH hoses are needed for a cost of $\$ 6,000$. He is asking for $\$ 15,000$ from FF Inc. for those two items. Doug Noetzel made a motion that if the fire fighters vote for these two items and the Finance Committee approves it, to give Terry the $\$ 15,000 / 2^{\text {nd }}$ by Tom Birchell. Motion approved.
