The hedge around the flagpole is just about dead. We are looking for someone to facilitate working to get that project done. Karen, Melissa, Terri, and Terry Mantor volunteered to work on the project.

The Finance Committee approved \$4000 for a defibrillator for the fire hall and locator for the boat in March. The locator was stolen from the boat last year. The locator was paid in full by FF Inc. and reimbursed half by the town. The defibrillator is being billed to the town and FF Inc. will pay half when the invoice comes in. Thanks to Russ Schroeder for getting us a discount on the locator.

Jack Wierzba agreed FF Inc. could once again use his outbuilding for Hourly Raffle storage. He brought up the need for insurance on the contents. Terri Murrin suggested getting renter's insurance on Jack's outbuilding. We will be looking into pods or other storage devices for next year.

Connie Scott said she could provide Special Event Insurance for the day of the event for \$395. The town has insurance, but this would go above and beyond that coverage to cover things such as food, alcohol and any accidents. Terry said town insurance covers the facility the day of, but it needs to be made clear that FF Inc. puts on Fun Day not the Pike Lake Fire Department. Warren will be checking with the town again. It was suggested to get a copy of the policy and also clarify who is running Fun Day.

Septic update: A bad valve was replaced on the water filter. Water is still seeping into and filling up the tank. The water is clear. It will have to be drained in the spring and investigated further.

Toilet update: Contact has been made with a local plumber and hopefully the men's toilet in the fire hall will be replaced soon. Rick will replace the flap valve in the women's toilet.

A website and Facebook page have been created for Pike Lake Firefighters, Inc. A big thanks to Derek Dieringer for creating those two pages.

If anybody has photographs of past Fun Days, Lynne would like to make a presentation to be viewed at Fun Day.

Gatherer letters for the hourly raffle prizes will be coming out soon, along with worker letters.

Thanks to the Warren Family Defibrillator Fund (Sironi family) for donating an AED to the Fire Department/EMS.

Russ said how lucky we are to have this wonderful organization.

Fire Chiefs Report:

Warren Johnson reported three EMS and no fire calls last month. The department applied for and received a Flex Grant for \$150,000 to be used to purchase a Rural Trail Rescue vehicle, three practice mannequins, a search and rescue drone, and an automatic CPR machine. Our EMS team trains with Sherman and Fifield once a month. Training locations rotate. The public is welcome to come and watch.

We have four new certified fire fighters: Ann Sloane, Mary Dupke-Bourgeois, Melissa Dupke-Bourgeois, and Jon Tornberg. There are now 14 members on the Fire/EMS team.

Our department recently attended a wildfire training exercise and a propane training.

Our repeater wire was replaced by FEMA as it was broken and hindering communications.

There is a extrication training coming up in May. The community is welcome to come and watch.

Eight SCBA bottles were replaced that were out of compliance.

Seven new sets of turnout gear were purchased because it was out of compliance.

All EMS personnel are being outfitted with new equipment bags that will be in compliance with state mandates.

The toilet in the men's bathroom is cracked. local contractor will be contacted to do the work.

The floor in the Building #1 is uneven. We found someone willing to pour new concrete, however we need someone to take out old cement and rebar. If you know someone, please contact Warren.

Remember our Blood Drive is May 5th. It is important to sign up in advance. We need a minimum of 30 people.
