Ed Clemens has had two responses from his contacts regarding liability insurance. This liability coverage is for prize storage and for the actual Fun Day event. Two quotes have been received. Connie Scott's quote for this coverage was from March. Connie is confirming the price with the broker in case there may be a price increase. Ed was given the go ahead to secure the coverage. The initial quote was $\$ 403$ for the coverage that was requested in March.

The pricing for corn sales is still being reviewed. Terri Murrin to check with Roy Funk regarding what the Sherman Corn Roast will charge per ear. The team supported returning the cost to $\$ 1.00$ per ear. Jim Brandt has asked that the corn donation remain in the name of the Dan Brandt Family.

Lynne Clemens reported that she was more than satisfied with the individual donations she has received and is okay from a staffing perspective. She and Ed will be picking up the needed TVs at Walmart based on the grant that was received. There will be three TVs used at Fun Day - two will be part of the hourly raffle while the third will be a fire department presentation done by Melissa DupkeBourgeois.

Lynne also reported that the tables have been delivered that were discussed at June's meeting. There are four tables each at a cost of \$163.75.

Lynne has received some silent auction items which included a Milwaukee Buck's jersey and a camping cot and stove. Mark Kelleher will also donate a corn hole game for the silent auction. A Brewer's jersey has also been received for the silent auction. Brewer's tickets are also expected.

Terry Mantor indicated that he will solicit individuals for the set up and tear down for Fun Day.
Catie Gunderson has secured a refrigerated trailer from Pepsi.
Mike Grandy reported on behalf of Nancy Grandy that the cash raffle is progressing well. Although unexpected, moving the raffle table to the gate of the transfer station has worked out well. Nancy received a donation of a canopy from Paul Seul which has helped greatly in this new Transfer Station location. Once the Transfer Station staffing ends for Fun Day (July $26^{\text {th }}$ ), tickets and cash can be placed in the lock box outside the fire station. A sign will be made for this purpose so that people are aware.

Paul Withey reported he is all set with the card raffle. He has seven raffle items which is the same as last year.
Rick Sironi reported via email. "Mike Ida and I completed the inventory of supplies for Fun Day and have given a list of things to be ordered to Catie Gunderson. We met with Greg and Bridget Pawell as they had volunteered to provide and make meatball subs. There is no cost to the FFI for these and will provide a beef sandwich to go with the pork. This is something we heard a lot of grumbling about last year. We decided to reduce the amount of pork from 375 lb last year to 225 lb . We had a lot of pork left after last Fun Day. We adjusted the bun count as well as the Pawell's will be supplying the buns for the meatballs. We have a small list of items to purchase at Walmart or another vendor (i.e., ketchup, mustard, etc).

We still need to determine the sandwich prices as we see the pork prices. We're thinking $\$ 5$ for the meatball subs. We COULD make the pork the same and adjust the size, or keep them large with a higher price, but we should wait on this decision.

Catie is also looking at dessert options as the cookies DIDN'T work last year. Hopefully she'll have some ideas soon."
Volunteers are needed to work in the kitchen. Ed to speak with Pam Kippes.
Sandy Guerard is in need of prizes for the kids' games. Ed Clemens to post on the Pike Lake Chain's "Too good for the Compactor" site regarding this need. A motion was made to set aside up to $\$ 300$ for the kids' games if needed by Jim Nelson/2nd by Terry Mantor.

Russ Schroeder confirmed that he had 10 items for the silent auction and confirmed that tables will be set up by the team for his use.
A $30^{\prime} \times 30^{\prime}$ area is needed for the fly-fishing exhibition. Terry Mantor suggested locating this activity near the horseshoe pits. This activity would be for children and adults.

Terry Mantor is to speak with Mike Ida regarding garbage pick-up.
Ed Clemens indicated that he had done some research and a 4-speaker sound system would run about \$2,000 while a 2-speaker sound system would be in the $\$ 900$ range. Ed has secured a borrowed unit for use at Fun Day if needed.

Jim Nelson reported that pull tabs have been purchased and delivered.

## New Business

Although out of scope for FFI, Paul Withey suggested that the Transfer Station be named after Dan Brandt. Warren will approach the Town of Fifield regarding this.

A September appreciation party for Fun Day volunteers was brought up.

## Fire Chief's Report:

There were six EMS calls during June. Three of these calls came on the same day. There were no fire calls. One of the EMS calls included two critical patients utilizing all of the available EMS staff. Both accident victims required Flight For Life.

Following a discussion regarding a 911 call that was not responded to by Pike Lake EMS, Chief Johnson explained the background regarding the call for an ill resident. Those present appreciated Warren's explanation and better understood the circumstances surrounding this incident. Chief Johnson has performed a review of the situation and necessary follow-up to ensure a response in the future. The lack of response was not related to any prior staff incident.

As discussed at our June meeting, those present supported the purchase of a refrigerator magnet with the procedure for contacting 911 in Price County. 911 cell phone calls are currently routed through Vilas County with follow up contact to Price County dispatch. The magnets would be distributed at Fun Day. Chief Johnson will handle putting the magnet together for Fun Day distribution.

A discussion of cell phone signals and the use of satellite phones took place. Jerry Jeske will look further into the use of satellite phones for the fire and EMS teams and report back to the group.

## Motion to Adjourn:

A motion to adjourn was made by Terry Mantor $/ 2^{\text {nd }}$ Paul Withey. Motion carried. Meeting adjourned at 8:10 pm.
