Warren reported that there were some purchases made since last fall: a scene light (part of cost was paid from the flex grant), ramps for brush truck, battery powered ice auger, 14 flashlights, an ice rescue suit, battery operated spreader and raffle licenses.

The rural rescue vehicle purchase was delayed due to suspension part issues from the manufacturer. It is being paid for by the Flex Grant.

FF Inc Finance Committee was asked to approve the money for a new mini-pumper. It should arrive in a few months. By selling the squad it will pay for the mini-pumper and no money would then be needed from FF Inc.

There was a rollover on Hwy 70 last week. No injuries. There were approximately three calls since the first of the year.
